- Employee Safety & Awareness Guides (English or Spanish)

We won't take a 3% membership due from employee's checks. We only charge a yearly \$25 membership due.

Our grievance procedure mediates issues between the employer – employee that can save everyone the headaches of potential lawsuits.

Our Neutrality Clause assures no workstoppage, picketing or boycotting from our members.

We are the carriers of our own ERISA-based benefits (Workers' Comp, Health Care, Retirement, etc.), therefore guaranteeing savings to employers and employees alike on the benefits that matter the most.



Affirmative Workers' Compensation Benefit (AWCB) is a legally compliant ERISA-based benefit under Federal law, known as an employee welfare benefit to cover events that could occur onthe-job, such as accidents or illnesses, and can only be offered to our Union members. This Workers' Comp benefit needs to be more encompassing than regular Workers' Comp products sold in the market. Our AWCB offers a \$4,000 funeral expense benefit, free annual employee physicals and annually updated immunizations.
